The Guidelines for the Awarding of the Bronze Wolf

The Bronze Wolf

The Bronze Wolf was established in 1935. It is the only **distinction awarded by the World Organization of the Scout Movement (WOSM)** and is granted at the sole discretion of the **World Scout Committee (WSC)**, under Article XIV, 1. (n) of the WOSM Constitution upon recommendation of the **World Honours and Awards Committee (WHAC)** under Article XVI, 6.

1. Eligibility

- **1.1** The Bronze Wolf (BW) recognises outstanding service of the most exceptional character to the World Scout Movement typically at the world and/or regional levels.
- **1.2** Current members of the WSC and staff of the World Scout Bureau (WSB) are not eligible during their term of service.
- **1.3** In very exceptional circumstances, the WSC may may waive these restrictions
- **1.4** If a nominee passes away before the award is granted and communicated, the nomination process will automatically terminate.

2. Nominations

- **2.1** Nominations may be submitted by
 - 2.1.1 any elected member of the WSC;
 - 2.1.2 Regional Chairpersons;
 - 2.1.3 Chairpersons of WSC Standing Committees; and
 - **2.1.4** any current Bronze Wolf holder (except WHAC members).
- **2.2** All nominations must be made individualy.
- **2.3** Nominations are accepted year-round, following the WHAC calendar.
- **2.4** Nominations must be fully completed by the nominator.

3. Preliminary evaluation by WHAC

- 3.1 Members of WHAC are asked to review nominations in advance of meetings, where time allows.
- **3.2** The purpose of the preliminary evaluation is to:
 - **3.2.1** gather and circulate additional relevant information;
 - **3.2.2** to ensure that if further information is required, there is an opportunity to obtain such information before the actual meeting.
 - 3.2.3 Allow absent WHAC members to submit input in advance;
 - **3.2.4** Streamline meeting discussions.
- **3.3** Evaluation focuses on evidence of impact and exceptional services not age, tenure, attendance of events, or routine performance of duties. Ethical considerations are taken into account.
- **3.4.** The Secretary informs WHAC on any previous nominations and outcomes.
- **3.5** Nominations are classified as:
 - **3.5.1** Likely to merit the Bronze Wolf.
 - **3.5.2** Needs more information.

3.5.3 No further action.

A nomination may only be reconsidered if at least three [3] years have passed since the rejection of the WSC or decision made by WHAC and new, significant information is included.

4. Preparation of report and a ballot paper for WSC

- **4.1** WHAC finalises a list, with four categories:
 - **4.1.1** Recommended for Bronze Wolf (pending NSO confirmation).
 - 4.1.2 Deferred.
 - **4.1.3** Terminated due to death.
 - 4.1.4 Closed (unless re-nominated).
- **4.2** For those recommended (4.1.1), WHAC discreetly seeks confirmation from the nominee's NSO that there are no ethical or safeguarding concerns.
- **4.3** WHAC prepares a ballot package for the elected members of the WSC, which includes:
 - 4.3.1 Nomination form(s).
 - **4.3.2** News article that will be used if the nominee is successful.
 - **4.3.3** Reminder of Article XIII, 1: WSC members act in the interests of the Movement as a whole.
 - **4.3.4** Clarification on voting and abstentions.
 - **4.3.5** Option to confidentially explain "no" vote (if deemed necessary by WHAC Chair. In such a case, even if the vote is successful, the Chairperson of the WHAC, **after consulting the WHAC**, may decide to defer any award for further consideration. He or she will only do so if significant new information has been provided.

5. Voting by WSC Elected Members

- **5.1** A nominee is awarded the Bronze Wolf if:
 - **5.1.1** At least 7 WSC elected members cast their vote "in favour "(WSC Standing Orders).
 - **5.1.2** At least 75% of casted votes, are "in favour".
 - **5.1.3** Abstentions will not be counted.
- **5.2** The number of "against" votes is not disclosed to the WSC, but is known to the WHAC Chair.

Example of voting:

If 12 WSC members vote, 9 need to be in favour for the motion to carry.

If 11 WSC members vote, 9 need to be in favour for the motion to carry.

If 10 WSC members vote, 8 need to be in favour for the motion to carry.

If 9 WSC members vote, 7 need to be in favour for the motion to carry.

If 8 WSC members vote, 7 need to be in favour for the motion to carry.

If 7 WSC members vote, all 7 need to be in favour for the motion to carry.

6. Award Announcements

- **6.1** Upon WSC decision, the Secretary General of WOSM (SG) informs both the recipient and their NSO, announcing the award.
- **6.2** The public announcement should read: "The Bronze Wolf has been awarded by the World Scout Committee of the World Organization of the Scout Movement to [name] for outstanding service of the most exceptional character to the World Scout Movement".

Date and location of presentation may be included if known.

7. Presentation

- **7.1** WHAC arranges presentation at World or Regional events.
- **7.2** Awards are presented in order of BW number.
- **7.3** The recipient may nominate a Bronze Wolf Holder to present the Award (preferably from a different NSO)
- **7.4** In exceptional cases, where no BW holder is available to present the BW Award, WHAC will appoint a suitable presenter.
- **7.5** The recipient will receive:
 - 7.5.1 The Bronze Wolf medal

- **7.5.2** Uniform ribbons
- **7.5.3** An official certificate
- **7.5.4** A copy of the citation.
